Citizens wants to remind all our Internet customers of the dangers of illegal downloading of movies, television shows, games, and music from the Internet.

Downloading "free" content such as movies, games, or music is nothing new. It has been going on since the beginning of internet access. Free is good, right? So what is the problem? The problem is that most "free" content such as movies, games, or music has been placed or shared on torrent or pirate websites without the knowledge or consent of the copyright owner. In other words, it's illegal, and if you get caught, there are serious consequences.

For example, you are sitting at home on Saturday night and you want to watch a new movie. However, it isn't available to rent from any vending machine or store. Your only option is to purchase the movie for \$29.95. You decide that you don't want to pay that much. You search online and look for other options. You can find several links to watch or download the movie for free. You think this sounds like a good option? This thought would be wrong as you are a keystroke or click away from committing a serious crime, Copyright Infringement.

Peer-to-peer file-sharing websites or "torrents", allow users to download music from friends, neighbors and strangers anywhere in the world for free. This online piracy is a real problem and is covered by the Digital Millennium Copyright Act "DMCA". The DMCA was signed into law on October 28, 1998. Its intent was to protect copyright owners in the age of the internet and electronic file transfers.

Citizens receives notices from representatives of owners of copyrighted songs, movies, and television programs, and games that some of our customers have downloaded, copied and/or shared such files

from the Internet in violation of the DMCA. These notices identify the Internet Protocol (IP) addresses of the alleged violators. Citizens does not provide or share any IP or other information with the content owners. They obtain that information the moment you download or share the file through sophisticated tracking methods that they have created. The content owners reserve the right to take legal action against offenders. To meet Citizens' obligations, we notify customers of copyright infringements and maintain a "3 strikes and you're out" policy for customers with repeat violations.

When it comes to accessing and viewing online media, there are do's and don'ts.

- Do use legal streaming services: These are set up to allow users to view content whenever and wherever they want while protecting content owners. Most streaming services charge a fee (like Amazon Prime, Netflix, Paramount, Apple Music just to name a few). Even services that offer free streaming (like Spotify and Pandora) make revenue through advertisements.
- Do purchase legal content online: You can buy songs, albums, music and TV series from legitimate online websites such as Amazon Music or Amazon Prime.
- Do consult resources such as StreamSafely.com: This website breaks down the consequences of illegal media sharing and provides answers to common questions, such as "How do Pirates deliver content" and "Is it safe to watch pirated content?".
- Do restrict website access:
   Accessing illegal content on the
   internet is not always obvious,
   especially for a child, teen, or
   elderly family member. To keep
   your family protected, consider

- browser or Wi-Fi restrictions that prevent them from accidentally clicking on or visiting illegal content websites.
- Do password protect your Wi-Fi. Citizens' customers can also contact our 24/7 internet support at (800) 741-9525, and our Support Specialists will gladly assist in setting up or changing wireless passwords for your Wi-Fi router.
- Do keep your household informed and protected by talking to family members and sharing this information with them.
- Don't visit torrent or pirate websites, regardless of how tempting it may seem. Remember if it sounds too good to be true, it usually is.
- Don't accept a "free" movie, television show, game, or music from a friend, family member, etc. Most likely this "free" content was obtained illegally and content owners can trace this content.
